Transportation Committee – The transportation Committee notes indicate barriers such as Low and inconsistent usage and the need for on-demand services. Timing makes transportation for certain shifts difficult as well. Services start too late for those to get to jobs and need an interim strategy to fill gap before consolidation. One long term solution is a collaborative funding model by providers in the area, pooling funding to supplement cost of broader transportation plans. Community is changing and turning over. Newer residents are not as familiar with routes and timing.

Tenants Association has become inactive due to lack of meeting locations and slow movement of the AGN activities. There is a need to reengage residents back into this process and involve all aspects of neighborhood, students, residents, businesses.

The Committee discussed the need for healthcare options and the need for improved transportation to healthcare with expansion of DeKalb County Health Department. Some options include expanding FQHC, School of Nursing, Speech and Hearing Clinic, CHHS.

Communication/Awareness Campaign. Making information more readily available on social services and programs.

Goal – Engage residents in the community
