PRESS RELEASE

On February 21st, 2016, the DeKalb Police Department, which was assisted by the DeKalb County Sheriff's Office, Northern Illinois University Police Department, Sycamore Police Department and the DeKalb County States Attorney's Office, concluded numerous drug related investigations that resulted in twenty nine arrest warrants being issued. This collaborative effort between the agencies resulted in the seizures of Cocaine, LSD, Methamphetamine, Xanax/Alprazolam, MDMA, Adderall, Cannabis, drug paraphernalia and United States Currency.

The following subjects have been arrested on the warrants that were issued for their arrest:

Anthony Montes, 21 years of age; from Sycamore, Illinois was arrested for Unlawful Delivery of a Controlled Substance within a 1000' of a school, Unlawful Delivery of a Controlled Substance and Unlawful Possession of a Controlled Substance.

Stefania C. Gelazius, 22 years of age; from Chicago, Illinois was charged with Unlawful Delivery of a Controlled Substance within a 1000' of a park, Unlawful Delivery of a Controlled Substance within a 1000' of a School, Unlawful Delivery of a Controlled Substance and Unlawful Possession of a Controlled Substance.

Andrew D. Meinke, 22 years of age; from DeKalb, Illinois was charged with Unlawful Possession of a Controlled Substance, Unlawful Possession of Drug Paraphernalia and Unlawful Possession of Cannabis.

Julie A. Burton, 35 years of age; from Rockford, Illinois was charged with Unlawful Possession of a Controlled Substance. Barton's bond was set at \$5,000.

Courtney L. Schaus, 21 years of age; from Montgomery, Illinois was charged with Unlawful Possession of a Controlled Substance. Schaus' bond was set at \$5,000.

Kevin L. White, 51 years of age; from DeKalb, Illinois was charged with Unlawful Possession of a Controlled Substance, Unlawful Possession of Cannabis with the Intent to Deliver and Unlawful Possession of Cannabis. White's bond was set at \$5,000.

Patrick J. Brantner, 25 years of age; from DeKalb, Illinois was charged with Unlawful Delivery of a Controlled Substance within a 1000' feet of Church, Unlawful Delivery of a Controlled Substance and Unlawful Possession of a Controlled Substance. Brantner's bond was set at \$15,000.

Sarah J. Riley, 26 years of age; from Sycamore, Illinois was charged with Unlawful Delivery of a Controlled Substance within a 1000' of a Park, Unlawful Delivery of a Controlled Substance and Unlawful Possession of a Controlled Substance. Riley's bond was set at \$30,000.

Matthew J. Shless, 23 years of age; from DeKalb, Illinois was charged with Unlawful Possession of a Controlled Substance, Unlawful Possession of Cannabis and Unlawful Possession of Drug Paraphernalia. Shless' bond was set at \$5,000.

Stacy A Muir, 26 years of age; from DeKalb, Illinois was charged with Unlawful Possession of a Controlled Substance and Unlawful Possession of Drug Paraphernalia. Muir's bond was set at \$10,000.

Mitchell, 21 years of age; from DeKalb, Illinois was charged with Unlawful Possession of a Controlled Substance with the Intent to Deliver within a 1000' of a Church, Unlawful Possession of a Controlled Substance with the intent to Deliver, Unlawful Possession of Cannabis with the Intent to Deliver, Unlawful Possession of Cannabis, Unlawful Possession of a Controlled Substance and Unlawful Possession of Drug Paraphernalia. Mitchell's bond was set at \$20,000.
