RESOLUTION 2020-011

AUTHORIZING THE WAIVER OF COMPETITIVE BIDDING AND APPROVING THE PURCHASE OF WATER METERS AND RADIO TRANSMITTERS FROM BADGER METER, INC. AND CORE & MAIN IN AN AMOUNT NOT TO EXCEED \$50,000.

PASSED: JANUARY 27, 2020

WHEREAS, The City of DeKalb operates a potable water system which includes the repair and maintenance of over 11,000 water meters in order to maintain accurate and efficient water meter reading and billing; and

WHEREAS, The City of DeKalb has used Badger and Sensus brand water meters for a number of years and, due to the proprietary nature of the meter radio reading devices, software and equipment, the purchase of meters through an alternative meter company would necessitate the need to obtain additional software and hardware in order to read the meters; and

WHEREAS, the City of DeKalb Utility Division wishes to not maintain an extraordinary amount of meter stock on hand, but rather purchases meters on an as-needed basis throughout the fiscal year; and

WHEREAS, the City of DeKalb Utility Division has secured quotes from both Badger Meter, Inc. and the Core & Main on a per unit basis for the purchase of water meters and radio transmitters.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS AS FOLLOWS:

SECTION 1: That the City Council of the City of DeKalb hereby authorizes the waiver of competitive bidding and approval of the purchase of water meters and radio transmitters from Badger Meter, Inc. and Core & Main in an amount not to exceed \$50,000.

SECTION 2: That the City Clerk or the Executive Assistant shall be authorized and directed to attest the Mayor's Signature.
