AUTHORIZING AN ASSIGNMENT OF AGREEMENT FOR LEGAL SERVICES TO DONAHUE & ROSE. PC.

PASSED: MARCH 9, 2020

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government pursuant to the provisions of Article VII, Section 6 of the Illinois Constitution of 1970;

WHEREAS, on April 22, 2019, the City Council adopted Resolution 2019-073, which authorized an agreement for legal services between the City and the law firm Rosenthal, Murphey, Coblentz, and Donahue (the "Agreement");

WHEREAS, City Attorneys John Donahue and Matthew Rose have primarily provided legal services to the City under the Agreement;

WHEREAS, the law firm of Rosenthal, Murphey, Coblentz, and Donahue is being dissolved, and City Attorneys John Donahue and Matthew Rose will practice law at the law firm of Donahue & Rose, an Illinois professional corporation;

WHEREAS, paragraph 14 of the Agreement permits the City to assign the Agreement to the law firm of Donahue & Rose, PC;

WHEREAS, the assignment of the Agreement does not affect the material terms of the Agreement including, but not limited to, the legal services provided and compensation for the legal services provided;

WHEREAS, the City's corporate authorities find that it is in the best interests of the City to approve the assignment of the Agreement to Donahue & Rose, PC; and

THEREFORE, BE IT RESOLVED by the City Council of the City of DeKalb, Illinois, as follows:

SECTION 1: The recitals to this resolution are incorporated into and made a part of this Resolution as if fully set forth herein.

SECTION 2: The corporate authorities of the City of DeKalb approve and ratify the assignment of the Agreement entitled Retainer Agreement for City Attorney Services dated April 22, 2019 to the law firm of Donahue & Rose, PC.

SECTION 3: The City Clerk or Executive Assistant of the City of DeKalb, Illinois is authorized and directed to attest the Mayor's signature and shall be effective thereupon.
