

**AUTHORIZING PAYMENT TO IRVING CONSTRUCTION COMPANY, INC. IN THE AMOUNT OF \$45,000 FOR THE CONCRETE RECONSTRUCTION OF PALMER COURT IN CONJUNCTION WITH THE EGYPTIAN THEATRE RENOVATION PROJECT.**

**WHEREAS**, the City of DeKalb, DeKalb County, Illinois ("the City") is a home rule municipality with those powers granted under the provisions of the Illinois Constitution and the Illinois Municipal Code, 65 ILCS 5/1-1-1, *et seq.*; and

**WHEREAS**, the City maintains its public streets; and

**WHEREAS**, the City's corporate authorities have determined that it is advisable, necessary, and in the best interest of the public welfare to improve the streets, including the downtown business district facility of Palmer Court, all in accordance with the plans for the Egyptian Theatre renovation project and City's general specifications; and

**WHEREAS**, the City received a proposal from Irving Construction Company, Inc. to complete the work at a fair market price in conjunction with their efforts on the Egyptian Theatre renovation project.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:**


**SECTION 1:** That the City's corporate authorities select the sole source proposal of Irving Construction Company, Inc.

**SECTION 2:** That the City's corporate authorities approve, authorize and direct the Mayor or City Manager to enter into an agreement with Irving Construction Company, Inc. in a form acceptable to them for the concrete reconstruction of Palmer Court for \$45,000.

**SECTION 3:** That the City Clerk or the Executive Assistant of the City of DeKalb, Illinois be authorized and directed to attest the Mayor's signature and shall be effective thereupon.
