ORDINANCE 2021-005

AMENDING THE FISCAL YEAR-END DECEMBER 31, 2020 BUDGET OF THE CITY OF DEKALB, ILLINOIS.

PASSED: FEBRUARY 22, 2021

BE IT ORDAINED BY THE CITY COUNCIL of the City of DeKalb, Illinois, as follows:
