**AUTHORIZING AN AGREEMENT WITH DEKALB CORN CLASSIC AND KISHWAUKEE SUNRISE ROTARY CLUB FOR THE 2021 DEKALB CORN CLASSIC 5K/10K AND TASTE OF DEKALB EVENTS ON SEPTEMBER 26, 2021.**

**WHEREAS**, the City of DeKalb 2025 Strategic Plan envisions developing a positive, asset-based identity and brand for the City of DeKalb (the "City"); and

**WHEREAS**, the 2025 Strategic Plan encourages the City's partnerships with stakeholder groups to organize, encourage and participate in community events; and

**WHEREAS**, the DeKalb Corn Classic 5k/10k has been a long-standing annual event in the City; and

**WHEREAS**, the Taste of DeKalb is an event highlighting local restaurants and food trucks; and

**WHEREAS**, an agreement detailing the use of public rights of way to operate the 2021 Corn Classic 5k/10k and Taste of DeKalb is attached hereto and incorporated herein as Exhibit A.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:**

**SECTION 1:** The City's corporate authorities approve, authorize, and direct the Mayor to execute the Agreement in the same or substantially similar form as Exhibit A attached hereto and incorporated herein, and for the Mayor and City Staff to undertake all acts necessary to effectuate the Agreement.

**SECTION 2:** This resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that to the extent that the terms of this resolution should be inconsistent with any non-preemptive state law, that this resolution shall supersede state law in that regard within its jurisdiction.

**SECTION 3:** This resolution shall be in full force and effect from and after its passage and approval as provided by law.

**PASSED BY THE CITY COUNCIL** of the City of DeKalb, Illinois at a Regular meeting thereof held on the 23<sup>rd</sup> day of August 2021 and approved by me as Mayor on the same day.
