#### RESOLUTION 2022-012

PASSED: JANUARY 24, 2022

AUTHORIZING THE WAIVER OF COMPETITIVE BIDDING AND APPROVING THE PURCHASE OF WATER METERS AND RADIO TRANSMITTERS FROM BADGER METER, INC., AND CORE & MAIN IN AN AMOUNT NOT TO EXCEED \$80,000.

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, to maintain accurate and efficient water meter reading and billing for the City's potable water system, City Staff recommends purchasing water meters from Badger Meter, Inc. and radio transmitters from Core & Main as more fully described in the bid quotes attached hereto and incorporated herein as Group Exhibit A (the "Bid Quotes") in an amount not to exceed \$80,000; and

WHEREAS, the City's corporate authorities find that approving the purchase of the water meters and radio transmitters identified in the Bid Quotes in an amount not to exceed \$80,000 is in the City's best interests for the protection of the public health, safety, morals and welfare, and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

**SECTION 1:** The City's corporate authorities approve, authorize, direct, and ratify the City Manager to negotiate and execute agreements, in forms acceptable to him, with Badger Meter, Inc. and Core & Main, for the purchase of water meters and radio transmitters as more fully described in the Bid Quotes attached hereto and incorporated herein as Group Exhibit A, in a total amount not to exceed \$80,000.

**SECTION 2:** This resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that to the extent that the terms of this resolution should be inconsistent with any non-preemptive state law, that this resolution shall supersede state law in that regard within its jurisdiction.


**SECTION 3:** This resolution shall be in full force and effect from and after its passage and approval as provided by law.


