RESOLUTION 2022-016

PASSED: FEBRUARY 14, 2022

AUTHORIZING THE PURCHASE OF TWO (2) FORD F-250 SUPER DUTY PICKUP TRUCKS THROUGH MORROW BROTHERS FORD FOR THE PUBLIC WORKS STREET DIVISION IN AN AMOUNT NOT TO EXCEED \$79,950.

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, the City's corporate authorities find that approving the purchase of two (2) Ford F-250 pickup trucks for the City's Public Works Street Division in an amount not to exceed \$79,950 is in the City's best interests for the protection of the public health, safety, and welfare; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The City's corporate authorities authorize, approve, direct and ratify the City Manager to negotiate and execute a purchase agreement, in a form acceptable to him, with Morrow Brothers Ford, to purchase two (2) new Ford F-250 Pickup Trucks for the City's Public Works Street Division in a total amount not to exceed \$79,950.00.

SECTION 2: This resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the City of DeKalb that to the extent that the terms of this resolution should be inconsistent with any non-preemptive state law, that this resolution shall supersede state law in that regard within its jurisdiction.

SECTION 3: This resolution shall be in full force and effect from and after its passage and approval as provided by law.
