

RESOLUTION 2022-048

PASSED: MAY 23, 2022

AUTHORIZING A PAYMENT TO THE DEKALB COUNTY COMMUNITY FOUNDATION ON BEHALF OF THE DEKALB MUNICIPAL BAND FOR SERVICES BEGINNING JANUARY 1, 2022, THROUGH DECEMBER 31, 2022, IN THE AMOUNT \$41,088.

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, the City's corporate authorities previously authorized the provision of funding not to exceed \$41,088.00 to the DeKalb Municipal Band (the "Band") for the 2022 Fiscal Year ("FY2022"); and

WHEREAS, the City's corporate authorities find that approving said funding is in the City's best interests for the promotion of the public health, safety, morals and welfare; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The City's corporate authorities authorize and approve payment of funds pledged for expenses of the Band for FY2022 to the DeKalb County Community Fund in the amount of \$41,088.00.

SECTION 2: This resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that to the extent that the terms of this resolution should be inconsistent with any non-preemptive state law, that this resolution shall supersede state law in that regard within its jurisdiction.

SECTION 3: This resolution shall be in full force and effect from and after its passage and approval as provided by law.

PASSED BY THE CITY COUNCIL of the City of DeKalb, Illinois at a Regular meeting thereof held on the 23rd day of May 2022 and approved by me as Mayor on the same day. Passed by an 8-0 roll call vote. Aye: Morris, Larson, Smith, Perkins, McAdams, Verbic, Faivre, Barnes. Nay: None.
