

RESOLUTION 2022-052

PASSED: JUNE 13, 2022

AUTHORIZING BROWN EQUIPMENT COMPANY TO MAKE REPAIRS TO THE PUBLIC WORKS COMBINATION VACUUM/FLUSHER TRUCK (VACTOR) IN AN AMOUNT NOT TO EXCEED \$51,026.

WHEREAS, the City of DeKalb (the City) is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, City Staff negotiated with Brown Equipment Company to perform necessary repairs to the City's Vactor truck in an amount not to exceed \$51,025 as set forth in the estimate attached hereto and incorporated herein as Exhibit A (the Estimate); and

WHEREAS, the City's corporate authorities find that approving the Estimate is in the City's best interests for the protection of the public health, safety, and welfare; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The City's corporate authorities authorize, approve, direct and ratify the City Manager or his designee to enter into an agreement with Brown Equipment Company, in a form acceptable to the City Manager or his designee, to repair the City's combination vacuum/flusher truck (Vactor) in an amount not to exceed \$51,026 as set forth in the Estimate.

SECTION 2: This resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the City of DeKalb that to the extent that the terms of this resolution should be inconsistent with any non-preemptive state law, that this resolution shall supersede state law in that regard within its jurisdiction.

SECTION 3: This resolution shall be in full force and effect from and after its passage and approval as provided by law.

PASSED BY THE CITY COUNCIL of the City of DeKalb, Illinois at a Regular meeting thereof held on the 13th day of June 2022 and approved by me as Mayor on the same day. Passed by an 8-0 roll call vote. Aye: Morris, Larson, Smith, Perkins, McAdams, Verbic, Faivre, Barnes. Nay: None.
