

**AMENDING CHAPTER 51 "TRAFFIC", SCHEDULE C "PARKING PROHIBITED", OF THE CITY OF DEKALB, ILLINOIS MUNICIPAL CODE AS IT PERTAINS TO CHANGING THE TOW ZONE TIME FROM 2:00 A.M. TO 12:00 A.M.**

**WHEREAS**, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

**WHEREAS**, Chapter 51 of the City's Municipal Code (the "Code") regulates traffic within the City's corporate limits; and

**WHEREAS**, the City's corporate authorities find that it is in the City's best interests for the protection of the public health, safety, welfare, and morals to amend Chapter 51 of the Code pursuant to the provisions of this Ordinance; and

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEKALB, ILLINOIS:**

**SECTION 1:** The recitals to this ordinance are adopted and incorporated herein as Section One to this Ordinance.

**SECTION 2:** The City's corporate authorities adopt and approve an amendment to Chapter 51 "Traffic", Schedule C, "Parking Prohibited", of the City's Municipal Code as follows (additions are indicated by double underlining and deletions are indicated by ~~striketrough~~ markings):

**Arcadia Drive**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, south side, from a point 29 feet east of the east right-of-way line of North Annie Glidden Road to Rushmore Drive.

\* \* \*

**Aspen Court**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, south and west sides, from West Hillcrest Drive to its north terminus, excluding the cul-de-sac.

\* \* \*

**Blackhawk Road**, Permitted Parking Only 12:00 a.m. to 6:00 a.m., Tow Zone, east side, from a point 75 feet south of the south right-of-way line of Ridge Drive to a point 75 feet north of the north right-of-way line of Edgebrook Drive.

\* \* \*

**Blackhawk Road**, Permitted Parking Only 12:00 a.m. to 6:00 a.m., Tow Zone, east side, from a point 82 feet south of the south right-of-way line of Edgebrook Drive to a point 42 feet north of the north right-of-way line of Kimberly Drive.

**Blackhawk Road**, Permitted Parking Only 12:00 a.m. to 6:00 a.m., Tow Zone, east side, from a point 65 feet south of the south right-of-way line of Kimberly Drive to a point 104 feet north of the north right-of-way line of West Hillcrest Drive.

**Eco Park Drive**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, south side, from the south terminus of Fotis Drive to Regent Drive.

\* \* \*

**Fotis Drive**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, west side, from West Hillcrest Drive to the west terminus of Eco Park Drive.

**Garden Road**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, east side, from a point 75 feet south of the south right-of-way line of West Hillcrest Drive to a point 798 feet north of the north roadway line (extended) of Northern Lane

\* \* \*

**Garden Road**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, east side, from a point 630 feet north of the north right-of-way line of Lucinda Avenue to a point 253 feet north of the north right-of-way line of Lucinda Avenue.

**West Hillcrest Drive**, Permitted Parking Only 12:00 a.m. to 6:00 a.m., Tow Zone, north side, from a point 158 feet east of the east right-of-way line of Blackhawk Road to a point 233 feet west of the west right-of-way line of Normal Road.

\* \* \*

**West Hillcrest Drive**, Permitted Parking Only 12:00 a.m. to 6:00 a.m., Tow Zone, south side, from a point 120 feet east of the east right-of-way line of Blackhawk Road to a point 315 feet west of the west right-of-way line of Normal Road.

**Normal Road**, Permitted Parking Only 12:00 a.m. to 6:00 a.m., Tow Zone, west side, from a point 298 feet south of the south right-of-way line of Ridge Drive to a point 70 feet north of the north right-of-way line of Edgebrook Drive.

\* \* \*

**Pappas Drive**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, west side, from West Hillcrest Drive to Varsity Boulevard.

\* \* \*

**Regent Drive**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, west side, from a point 60 feet north of the north right-of-way line of Eco Park Drive to its north terminus.

**Ridge Drive**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, south side, from a point 85 feet west of the west right-of-way line of Rushmoore Drive to a point 20 feet west of the west right-of-way line of Rushmoore Drive.

\* \* \*

**Ridge Drive**, Permitted Parking Only 12:00 a.m. to 6:00 a.m., Tow Zone, south side, from Rushmoore Drive to a point 60 feet west of the west right-of-way line of Blackhawk Road.

**Ridge Drive**, Permitted Parking Only 12:00 a.m. to 6:00 a.m., Tow Zone, south side, from a point 52 feet east of the east right-of-way line of Blackhawk Road to a point 512 feet west of the west right-of-way line of Normal Road.

**Ridge Drive**, Permitted Parking Only 12:00 a.m. to 6:00 a.m., Tow Zone, from a point 365 feet west of the west right-of-way line of Normal Road to a point 66 feet west of the west right-of-way line of Normal Road.

\* \* \*

**Ridge Drive**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, south side, from a point 100 feet east of the east right-of-way line of Normal Road to a point 243 feet east of the east right-of-way line of Normal Road.

\* \* \*

**Spiros Court**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, west side, from its north terminus to its south terminus, excluding the cul-de-sacs on either end.

\* \* \*

**Varsity Boulevard**, No Parking 12:00 a.m. to 6:00 a.m., Tow Zone, south side, from a point 75 feet east of the east right-of-way line of Regent Drive to a point 340 feet east of the east right-of-way line of Regent Drive, and from a point 447 feet east of the east right-of-way line of Regent Drive to a point 748 feet east of the east right-of-way line of Regent Drive, and from a point 872 feet east of the east right-of-way line of Regent Drive to a point 1101 feet east of the east right-of-way line of Regent Drive, and from a point 1214 feet east of the east right-of-way line of Regent Drive to a point 35 feet west of the west right-of-way line of North Annie Glidden Road.

**SECTION 3:** This Ordinance and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such ordinance should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that to the extent this Ordinance is inconsistent with any non-preemptive state law, this Ordinance shall supersede state law in that regard within its jurisdiction.

**SECTION 4:** Except as may otherwise be amended by this ordinance, Chapter 51 of the Code shall remain in full force and effect.

**SECTION 5:** Should any provision of this Ordinance be declared invalid by a court of competent jurisdiction; the remaining provisions will remain in full force and affect the same as if the invalid provision had not been a part of this Ordinance.

**SECTION 6:** This ordinance shall be in full force and effect after its passage and approval as provided by the law.
