AUTHORIZING THE PURCHASE OF TWO FORD E-450 TYPE ILL OSAGE AMBULANCES FROM NORTH CENTRAL EMERGENCY VEHICLES PLUS UPFITTING EXPENSES NECESSARY TO PLACE THE AMBULANCES IN SERVICE IN AN AMOUNT NOT TO EXCEED \$431,084.

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, the City's Fire Chief recommends entering into an agreement with North Central Emergency Vehicles for the purchase of two (2) Class III Ford E-450 Osage ambulances plus upfitting expenses in a total amount not to exceed \$431,084.00 (the "Agreement"); and

WHEREAS, the City's corporate authorities find that it is in the City's best interests for the promotion of the public health, morals and welfare to authorize the negotiation and execution of the Agreement pursuant to the provisions of this Resolution; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The City's corporate authorities authorize, approve, direct, and ratify the City's Fire Chief or his designee to negotiate and execute an agreement on the City's behalf with North Central Emergency Vehicles for the purchase of two (2) Class III Ford E-450 Osage ambulances plus up-fitting expenses including, but not limited to, equipment, graphics and lettering, in a total amount not to exceed \$431,084.00, and such other terms and provisions that the City's Fire Chief or his designee may deem advisable.

SECTION 2: This resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that to the extent this resolution is inconsistent with any non-preemptive state law, this resolution shall supersede state law in that regard within its jurisdiction.

SECTION 3: This resolution shall be in full force and effect from and after its passage and approval as provided by law.
