RESOLUTION 2023-009

AUTHORIZING THE PURCHASE OF A 2023 FREIGHTLINER LR8-56 AERIAL TRUCK FROM GLOBAL RENTAL COMPANY IN AN AMOUNT NOT TO EXCEED \$148,720.

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, the City's corporate authorities find that approving the purchase of one (1) Freightliner Aerial for the Public Works Street Division is in the City's best interests for the protection of the public health, safety and welfare; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The City's corporate authorities approve, authorize, and direct the City Manager to execute an agreement, in a form acceptable to the City Manager, with Global Rental Company, to purchase one (1) new Freightliner Aerial in an amount not to exceed \$148,720.

SECTION 2: This resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the corporate authorities of the City of DeKalb that to the extent that the terms of this resolution should be inconsistent with any non-preemptive state law, that this resolution shall supersede state law in that regard within its jurisdiction.

SECTION 3: This resolution shall be in full force and effect from and after its passage and approval as provided by law.
