

AMENDING THE MUNICIPAL CODE OF THE CITY OF DEKALB, ILLINOIS CHAPTER 51, "TRAFFIC," SECTION 51.13, "PARKING PROHIBITED," SCHEDULE C, "PARKING RESTRICTIONS," SECTION 51.21 "REGULATING AND PARKING OF MOTOR VEHICLES DURING SNOW EMERGENCY; ESTABLISHING SNOW EMERGENCY ROUTES, AND SCHEDULE I, "SNOW EMERGENCY ROUTES" FOR PARKING CHANGES AND SNOW ROUTE INCLUSION AND TOW ZONE WARNING ON EDGEBROOK DRIVE.

BE IT ORDAINED BY THE CITY COUNCIL of the City of DeKalb, Illinois as follows:

Section 1. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.13, "Parking Prohibited," Schedule C, 1, "No Parking At Any Time," be amended by adding the following in the appropriate place:

Edgebrook Drive, south side

Section 2. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.13, "Parking Prohibited," Schedule C, 47, "No Parking 10:00 a.m. to 4:00 p.m., Sunday, Monday, Wednesday and Friday be amended by deleting the following:

Section 3. That the Municipal Code of the City of DeKalb, Illinois, Chapter 51, Traffic, Section 51.21, "Regulating and Parking of Motor Vehicles During Snow Emergency; Establishing Snow Emergency Routes," Schedule C, 48, "No Parking 10:00 a.m. to 4:00 p.m., Tuesday, Thursday and Saturday" be amended by deleting the following:

~~Edgebrook Drive, south side~~

Section 4. That the Municipal Code of the City of DeKalb, Illinois, Chapter 51, Traffic, Section 51.13, "Parking Prohibited," Schedule I, "Snow Emergency Routes" be amended by adding the following in the appropriate place:

Edgebrook Drive from Blackhawk Road to Normal Road


Section 5. That each section, paragraph, sentence, clause and provision of this ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this ordinance, nor any part thereof, other than that part affected by such decision.

Section 6. That except as to the amendments heretofore mentioned, all Sections of the Municipal Code of the City of DeKalb, Illinois shall remain in full force and effect.

Section 7. Upon its passage and approval according to law, this Ordinance shall, by authority of the City Council be published in pamphlet form. On the tenth day after the date of publication, this Ordinance shall be in full force and effect. Publication date: October 23, 2012. Effective date: November 1, 2012.
