

AMENDING THE MUNICIPAL CODE OF THE CITY OF DEKALB, ILLINOIS CHAPTER 51, "TRAFFIC," SECTION 51.08, "THROUGH STREETS AND STOP INTERSECTIONS," SCHEDULE B, SECTION 2, "STOP INTERSECTIONS" FOR HEATHERFIELD LANE STOPPED TRAFFIC AT WILDFLOWER LANE AND SECTION 4, "YIELD INTERSECTIONS" FOR PEBBLECREEK COURT YIELD TRAFFIC AT HEATHERFIELD LANE

BE IT ORDAINED BY THE CITY COUNCIL of the City of DeKalb, Illinois as follows:

Section 1. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.08, "Through Streets and Stop Intersections," Schedule B, be amended by inserting, in the alphabetically appropriate places, the following:

2. Stop Intersections: In accordance with Section 51.08 the following streets are designated stop intersections:

<u>Through traffic on</u>	<u>Stop traffic on</u>
Wildflower Lane	Heatherfield Lane

Section 2. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.08, "Yield Intersections," Schedule B, be amended by inserting, in the alphabetically appropriate places, the following:

4. Yield Intersections: In accordance with Section 51.08, the following intersections are yield intersections as hereinafter described and, at the entrance to the yield intersections, the operator of a vehicle approaching a yield sign shall reduce speed and yield the right-of-way as required by law:

<u>Through Traffic on</u>	<u>Yield Traffic on</u>
Heatherfield Lane	Pebblecreek Court

Section 3. That each section, paragraph, sentence, clause and provision of this ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this ordinance, nor any part thereof, other than that part affected by such decision.

Section 4. That except as to the amendments heretofore mentioned, all Sections of the Municipal Code of the City of DeKalb, Illinois shall remain in full force and effect.

Section 5. Upon its passage and approval according to law, this Ordinance shall, by authority of the City Council be published in pamphlet form. On the tenth day after the date of publication, this Ordinance shall be in full force and effect. Publication date: December 11, 2012. Effective date: December 21, 2012.
