AUTHORIZING THE NORTHERN ILLINOIS UNIVERSITY ANNUAL CONTRIBUTION FOR INTEGRATED TRANSIT SERVICES.

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, on October 22, 2018, the City and Northern Illinois University ("NIU") entered into an intergovernmental agreement for integrated transit services (the "IGA"), which was duly approved by the City's corporate authorities by Resolution 2018-138; and

WHEREAS, the IGA provides that NIU's annual contribution for integrated transit services shall be a minimum of 40% of total costs of fixed route and paratransit services; and

WHEREAS, NIU contributes 20% of the total costs associated with the Route 19 that travels to south DeKalb, Park 88, and Gurler Road; and

WHEREAS, the IGA provides that the City and NIU shall approve a draft budget for NIU's annual contribution before the beginning of FY2023.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The City's corporate authorities authorize, approve, and ratify NIU's annual contribution for integrated transit services for FY2023 as follows:
