AMENDING CHAPTER 51 "TRAFFIC", SCHEDULE F "MUNICIPAL LOT PARKING", OF THE CITY OF DEKALB, ILLINOIS MUNICIPAL CODE AS IT PERTAINS TO NO PARKING HOURS FOR THE FROST MUNICIPAL LOT (EAST LOCUST STREET, BETWEEN N. SIXTH STREET AND N. SEVENTH STREET).

**WHEREAS**, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, Chapter 51 of the City's Municipal Code regulates traffic in the City's corporate limits; and

WHEREAS, the City's corporate authorities find that is in the City's best interests to amend the City's Municipal Code pursuant to the provisions of this Ordinance for the protection of the public health, safety, welfare and morals; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

**SECTION 1:** The City's corporate authorities adopt and approve an amendment to Chapter 51, "Traffic", Schedule F "Municipal Lot Parking", of the Code as follows:

Frost Municipal Lot, No Parking 2:00 a.m. to 5:00 a.m. Tuesdays and Thursdays, twenty-five (25) stalls of the parking lot located on the south side of East Locust Street, between North Sixth Street and North Seventh Street.

**SECTION 2:** This ordinance and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such ordinance should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that to the extent that the terms of this ordinance should be inconsistent with any non-preemptive state law, that this resolution shall supersede state law in that regard within its jurisdiction.

**SECTION 3:** This Ordinance shall be in full force and effect after its passage and approval as provided by law.
