NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The City's corporate authorities approve the minutes of the executive session meetings as indicated on the attached and incorporated Exhibit A (the "Executive Session Meetings Index"). Additionally, the City's corporate authorities find that the need for confidentiality still exists as to all or part of those minutes indicated as not being recommended for release on the Executive Session Meetings Index. Furthermore, the City's corporate authorities approve the destruction of the verbatim recordings of the executive session meetings which are older than 18 months and which the City's corporate authorities have approved the written minutes thereof. Finally, the City's corporate authorities authorize and direct the Executive Assistant/Recording Secretary to take all necessary actions to effectuate this resolution.

SECTION 2: This resolution shall be in full force and effect from and after its passage and approval as provided by law.


