WHEREAS, the City's corporate authorities find that approving the Plat of Road Dedication is in the City's best interests for the protection of the public health, safety, and welfare; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The recitals to this Ordinance are true, material, adopted, and incorporated as Section 1 to this Ordinance.

SECTION 2: The City's corporate authorities adopt, approve, and accept the Plat of Road Dedication. The City's corporate authorities further authorize and direct the Mayor and Executive Assistant to sign the Plat of Road Dedication and for the City Manager or designee to record this Ordinance and the Plat of Dedication in the DeKalb County Clerk and Recorder's Office.

SECTION 3: This Ordinance and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such ordinance should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that to the extent that the terms of this Ordinance is inconsistent with any non-preemptive state law, this Ordinance shall supersede state law in that regard in the City's jurisdiction.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
