

**AUTHORIZING THE PURCHASE OF ONE 2023 FORD POLICE INTERCEPTOR FROM SUTTON FORD OF MATTESON AT THE ILLINOIS CENTRAL MANAGEMENT SERVICES CONTRACT PRICING IN AN AMOUNT NOT TO EXCEED \$42,556.**

**WHEREAS**, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

**WHEREAS**, the City's corporate authorities find that approving the purchasing and equipping of one (1) 2023 Ford Police Interceptor in an amount not to exceed \$42,556 is in the City's best interests for the protection of the public health, safety, morals, and welfare; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:**

**SECTION 1:** The City's corporate authorities approve, authorize, direct, and ratify the City Manager to negotiate and execute agreements, in forms acceptable to the City Manager, with Sutton Ford for one (1) 2023 Ford Interceptors in an amount not to exceed \$40,556 and various vendors to replace up-fitting items of the vehicle in a total amount not to exceed \$2,000.

**SECTION 2:** This resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that to the extent that the terms of this resolution should be inconsistent with any non-preemptive state law, that this resolution shall supersede state law in that regard within its jurisdiction.

**SECTION 3:** This resolution shall be in full force and effect from and after its passage and approval as provided by law.

**PASSED BY THE CITY COUNCIL** of the City of DeKalb, Illinois at a Regular meeting thereof held on the 11<sup>th</sup> day of September 2023 and approved by me as Mayor on the same day.
