SUBJECT: Consideration of Updates to Public Transit Routes in 2025.

I. Summary

City of DeKalb Public Transit is proposing route changes to begin March 9, 2025, to allow for implementation of these changes to occur during the NIU Spring Semester break and continue with resumption of full transit service when NIU resumes Spring classes. The routes impacted include:

Route 10 and 11

- Remove Routes 10 and 11 from entering the Eco Park residential parking lot at request from the Residential Manager for Eco Park and re-route the service onto Fotis Dr.
- Discontinue Routes 10 and 11 from making a U-turn at the intersection of Twombly Rd and Rosenow Way, instead using Adam's Way to safely turn the routes around for the return trip down Twombly.

Route 18

- Re-routing Route 18 on the northbound trip to access Northwestern Medicine Immediate Care Sycamore.
- The proposed change allows access to a second medical facility and allows a better transfer point for Route 18 to and from Route 21.

Route 11

• The timing on the overnight Route 11 provides too much time on the north side of the route, causing the buses to have to hold up to 5 minutes to remain on time. The route will be re-timed to remove the excess time, which will not affect the times the route runs during the night.

Route 12 (Elburn Service)

 Due to increased requests for more weekend service on Route 12, staff propose increasing Route 12 Weekend service from two (2) to five (5) trips on Saturdays and up to six (6) trips on Sundays when NIU is in session.

Route 21 and Route 21 Tripper

- Streamline Route 21
- Revise the route flow to allow better on-time performance.
- Change the 21 Tripper hours from an on-demand route to a paratransit/Dial-A-Ride zone that can better service the communities of DeKalb and Sycamore.



Route 19

Route 19 ridership has increased since initiating twenty-four hours a day seven days a week in August 2023. Due to ridership increases, the route is struggling to remain on time from midmorning to late in the evening. This change removes the section traveling north on north First St. between Locust St. and Hillcrest Dr. and on Hillcrest Dr./ Seventh St. from north First St to Pleasant St. The modification allows the buses an additional recovery time prior to the next trip starting.

Staff estimate the cost for these changes will be approximately \$50,909.86 annually.

II. Route 10 and 11 Changes

A. Eco Park Revisions

Transit staff were contacted by the residential manager of the Eco Park apartments located at Eco Park Dr. and Regent Dr. Currently two routes (Route 10 and the overnight Route 11) enter the residential parking lot while traveling southbound on Regent Dr. For this portion of the route, the 10 and 11 both travel the same path. They make an initial stop outside the complex at the stop sign at the "L" intersection of Eco Park Dr. and Regent Dr.

The table below shows the current and revised path for these routes around the Eco Park Apartments:

B. Twombly Rd. Revision

Additionally, staff are proposing that the Routes 10 and 11 stop making a "U-turn" at the intersection of Twombly Rd. and Rosenow Way (see map insert #3). The staff feel that this is an unsafe action.

Staff propose to have the two affected routes modify their travel path to have the bus head east bound on Twombly Rd. after coming west.

Route 11 – The timing on the overnight Route 11 has too much time on the north side of the route, causing the buses to have to hold up to more than five minutes to remain on time on each trip. The route will still run once an hour from Midnight to 7:00 AM in full service and from 10:00 PM to 7:00 AM in break service. Transit staff will adjust the time points at Schnucks Grocery store and again at Ridge Dr. at Normal Dr. The route will be re-timed to remove the excess time (see timetable #1 for current times and timetable #2 for proposed times). The changes will not affect the times the number of runs performed during the night (see table on the following page):

III. Route 12

Transit staff are planning increased Elburn Metra weekend service based on comments received from the community. Currently, the service only operates for limited hours on the weekends, with increased service on Sunday afternoons when NIU is in session.

Staff seek to increase Saturday and Sunday service from two runs between DeKalb and Elburn to a minimum of five runs on Saturdays and Sundays when NIU is not in session. When NIU is in session (our Full-Service schedule), the Elburn route would offer up to seven runs on Sundays to accommodate a greater number of students returning for the week. A breakdown of the schedules may be found below:

IV. Route 18

Regarding Route 18, Transit staff have observed a need for additional transit access to Northwestern Medicine Immediate Care Sycamore, located on Gateway Dr. and Doser Dr. Currently that location is only served by Route 21, which covers Sycamore. The current 18 route and the revised 18 route are listed on the following page:



V. Route 21 and Route 21 Tripper

The transit program operates two fixed routes in Sycamore, the Route 21, which operates 7:00 AM – 10:00 PM / seven days a week and the Route 21 Tripper, which is a feeder route that operates 7:30 AM – 5:30 PM Monday – Friday.

The Route 21 Tripper was started to support the main Route 21 route as it had too much ground to cover. Staff have been monitoring ridership and have not seen growth on the feeder route when compared to the rest of the system. Overall, the Sycamore feeder route has been providing an average of 175 passenger trips per month, meaning the route provides, on average, 9 passenger trips per day, or slightly less than one trip per hour.

Based on this low ridership, the transit team plans to convert the feeder service into a dial-andride vehicle that would be restricted to operating in Sycamore. Overall transit services to Sycamore residents will not decrease. The way the service is delivered will change for better



efficiency. Non-ADA Residents who used to access the Sycamore flex route would now access that service on a call-and-ride basis to connect to the nearest fixed route. The transit team implemented a similar change to Cortland in 2023 with positive ridership increases.

The main advantage of converting the Route 21 Tripper to a vehicle demand response is to allow the vehicle to operate in dual usage to support both paratransit and fixed route services (vs. being restricted to operating on a low-ridership route). With the addition of this Sycamore Dial-A-Ride Zone, staff concurrently plan to reduce the number of stops on Route 21 to improve the route's on-time performance.


Map insert #7 Rt. 21 and 21 Tripper

VI. Route 19 changes

Ridership on Route 19 has increased more than 200% over the last year. The route went from having a monthly ridership that was just over 750 rides per month to just under 2,500 rides per month.

With this increase in ridership, staff noted this route has struggled to stay on-time during morning and afternoon rush hours. To alleviate the time issues, staff are proposing to shorten the length of the route by eliminating stops in the area generally bounded by First Street to the West, Hillcrest



Drive to the North, and Seventh Street to the East.

Four of the five stops that would be eliminated are already serviced by other routes. The Hillcrest Drive portion is already covered by the Route 18 for passengers wanting to go to KinderCare and the Seventh Street portion is covered by the Route 17 allowing transfers at Locust St and 2nd or Locust St and 6th (see map insert #12).
