Furthermore, the City's corporate authorities approve the destruction of the verbatim recordings of the executive session meetings that are older than 18 months and which the City's corporate authorities have approved the written minutes thereof. Finally, the City's corporate authorities authorize and direct the Executive Assistant/Recording Secretary to take all necessary actions to effectuate this resolution.

SECTION 2: This resolution shall be in full force and effect from and after its passage and approval as provided by law.
