

AUTHORIZING THE AWARD OF A CONTRACT TO D. RYAN TREE & LANDSCAPING SERVICE, LLC FOR HAZARDOUS TREE REMOVAL AND TREE PRUNING IN AN AMOUNT NOT TO EXCEED \$230,300.

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, the City's Public Works Department competitively bid hazardous tree removal and pruning services and determined that D. Ryan Tree & Landscaping Service, LLC (the "Contractor") submitted the lowest responsible bid in the amount of \$230,300.00 per the attached and incorporated Exhibit A (the "Bid"); and

WHEREAS, the City's corporate authorities find that approving the Bid is in the City's best interests for the protection of the public health, safety and welfare; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The recitals to this resolution are true, correct, adopted and incorporated as Section One to this resolution.

SECTION 2: The City's corporate authorities adopt and approve the Bid. The City's corporate authorities further approve, authorize, and direct the City Manager to: (1) negotiate and enter into an agreement with Contractor for the Bid; and (2) take all necessary acts to effectuate the award of the Bid to Contractor.

SECTION 3: This resolution shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that if this resolution is inconsistent with any non-preemptive state law, this resolution shall supersede state law in that regard within its jurisdiction.

SECTION 4: This resolution shall be in full force and effect from and after its passage and approval as provided by law.
