AUTHORIZING THE PURCHASE OF TWO FORD F250 PICKUPS THROUGH MORROW BROTHERS FORD IN AN AMOUNT NOT TO EXCEED \$137,399 FOR USE IN THE PUBLIC WORKS WATER DIVISION (FUND 620).

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs under Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, the City's Public Works Director recommends the purchase of two (2) Ford F250 pickup trucks for the Water Division from Morrow Brothers Ford in an amount not to exceed \$137,399.00 per the bid quotes attached and incorporated as Group Exhibit A (the "Quote"); and

WHEREAS, the City's corporate authorities find that approving the Quote is in the City's best interests for the protection of public health, safety and welfare; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The recitals to this resolution are true, material, adopted and incorporated as Section One to this resolution.

SECTION 2: The City's corporate authorities approve the Quote. The City's corporate authorities further authorize and direct the City Manager to: (1) negotiate and execute an agreement with Morrow Brothers Ford for the purchase of two (2) Ford F250 Pickup in an amount not to exceed \$137,399.00 per the Quote; and (2) take all necessary acts to effectuate the Quote.

SECTION 3: This resolution shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that to the extent that the terms of this resolution should be inconsistent with any non-preemptive state law, that this resolution shall supersede state law in that regard within its jurisdiction.

SECTION 4: This resolution shall be in full force and effect from and after its passage and approval as provided by law.
