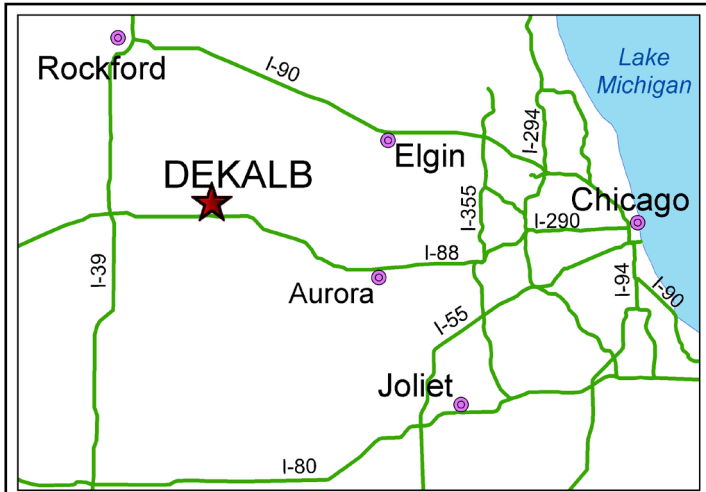

Community Profile

When you consider DeKalb, Illinois, as your next business location, you are considering a community which absolutely has it all! Founded as an agricultural community in 1837, DeKalb is 60 miles west of downtown Chicago. We're known as the home of Northern Illinois University and the birthplace of barbed wire, which changed farming methods throughout the world. We like to say we've gone from barbed wire, to fully wired. Working with NIU, the City boasts an 80-gig fiber network bridging the distance to Chicago, the region, and the world.

DeKalb is a regional hub, with easy access to the I-88 and I-39 corridors. Within the City, State Routes 38 and 23 make travel to the University, area shopping centers, and dining quick and convenient.

DeKalb is a city of 44,030 residents who live in 15,594 homes. The City of DeKalb represents more than a third of the population of DeKalb County, with families earning an annual median income of \$59,671 and owning homes with a median value of \$165,500. Employers in DeKalb provide more than 15,000 jobs, and commuters to classes at NIU further boost our daytime population and buying power.

Excellent educational partnership offerings between Kishwaukee College, Northern Illinois University, and DeKalb High School provide a full range of career readiness initiatives for our youth, allowing degrees to be earned at an accelerated pace. The Illinois workNet Center provides job training, job search services, basic computer literacy classes, and information about continuing education options. The Kishwaukee Community College Center for Business Development and Continuing Education offers opportunities for professional growth, personal enrichment, computer skills, and preparation for professional careers throughout our community. In addition, the DeKalb-Ogle Workforce Development Consortium collaborates with educators and businesses to work toward the inspiration and training of industrial professionals.

Major employers include Northern Illinois University, Kishwaukee Hospital, 3M, Target Distribution Center, Walmart, Sonoco Alloyed, Nestle Distribution, CST Storage, Forge Resources Group, and Aligus Packaging.

Art galleries, Kishwaukee Symphony Orchestra, the Municipal Band, live theater, arena concerts, independent films, and championship sports are all available in DeKalb. Add in more than 40 area parks, 10 miles of improved multi-purpose trails, Ellwood House museum, and the Art Deco Egyptian Theater, and there is always something to do in DeKalb.
