

ORDINANCE 2016-028

PASSED: AUGUST 8, 2016

**AMENDING THE FISCAL YEAR-END DECEMBER 31, 2016
BUDGET OF THE CITY OF DEKALB, ILLINOIS.**

WHEREAS, the City of DeKalb is a home-rule municipality with the powers and authority conferred upon it by virtue of the Illinois Constitution of 1970 and the Illinois Municipal Code; and

WHEREAS, on June 27, 2016, the Mayor and City Council of the City of DeKalb, DeKalb County, Illinois, adopted Ordinance No. 2016-018, approving the budget of the City of DeKalb for the fiscal year beginning July 1, 2016 and ending December 31, 2016, in the total amount of \$49,091,980 ("*FY16.5 Budget*"); and

WHEREAS, the City has identified the need to amend the FY16.5 Budget;

THEREFORE BE IT ORDAINED by the Mayor and City Council of the City of DeKalb, DeKalb County, Illinois, as follows:

Section 1. That, the City of DeKalb, which utilizes the Budget Process as contemplated by Article 8, Division 2 of the Illinois Municipal Code including but not limited to 65 ILCS 5/8-2-9.1 through 65 ILCS 5/8-2-9.10, adopts an amendment to its FY16.5 Budget, as shown below:

Section 2. All ordinances or portions thereof in conflict with this ordinance, including the prior versions of the ordinances included above, are hereby repealed.


Section 3. Should any provision of this Ordinance be declared invalid by a court of competent jurisdiction, the remaining provisions will remain in full force and affect the same as if the invalid provision had not been a part of this Ordinance.

Section 4. This Ordinance shall be in full force and effect after passage and publication pursuant to law. Publication date: August 9, 2016. Effective date: August 19, 2016.
