

AMENDING THE MUNICIPAL CODE OF THE CITY OF DEKALB, ILLINOIS, CHAPTER 51, "TRAFFIC," SECTION 51.09, "YIELD INTERSECTIONS," SCHEDULE B, "THROUGH STREETS, STOP INTERSECTIONS AND YIELD INTERSECTIONS," BY PROVIDING FOR TRAFFIC ON FURROW STREET, SUNGLOW LANE, HORIZON LANE, SETTLER ROAD AND GRANGE ROAD TO YIELD AT VARIOUS INTERSECTIONS.

BE IT ORDAINED BY THE CITY COUNCIL of the City of DeKalb, Illinois, as follows:

Section 1. That the Municipal Code of the City of DeKalb, Illinois, Chapter 51, "Traffic," Section 51.09, "Yield Intersections," Schedule B, "Through Streets, Stop Intersections and Yield Intersections," Subsection 4, be amended by inserting in the alphabetically appropriate places, the following:

4. Yield Intersections: In accordance with Section 51.09 the following intersections are yield intersections as hereinafter described and, at the entrance to the yield intersections, the operator of a vehicle approaching a yield sign shall reduce speed and yield the right-of-way as required by law:

<i>Devonaire Parkway</i>	<i>at</i>	<i>Sunglow Lane</i>
<i>Farmstead Lane</i>	<i>at</i>	<i>Grange Road</i>
<i>Horizon Lane</i>	<i>at</i>	<i>Grange Road</i>

Section 2. That each section, paragraph, sentence, clause and provision of this ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this ordinance, nor any part thereof, other than that part affected by such decision.

Section 3. That except as to the amendments heretofore mentioned, all Sections of the Municipal Code of the City of DeKalb, Illinois shall remain in full force and effect.

Section 4. Upon its passage and approval according to law, this Ordinance shall, by authority of the City Council, be published in pamphlet form. On the tenth day after the date of publication, this Ordinance shall be in full force and effect. Publication date: August 9, 2011. Effective date: August 19, 2011.
