

ORDINANCE 2014-10 Passed: April 28, 2014

**PUBLISHING THE OFFICIAL ZONING MAP
OF THE CITY OF DEKALB, ILLINOIS.**

BE IT ORDAINED BY THE CITY COUNCIL of the City of DeKalb, Illinois, as follows:

Section 1. Pursuant to 65 ILCS 5/11-13-19, the City of DeKalb shall annually publish the Official Zoning Map of the City. The Official Zoning Map of the City of DeKalb, as of April 14, 2014, a copy of which is attached to this Ordinance and labeled Exhibit "A," is hereby published and approved.

Section 2. The Official Zoning Map shall be filed and available for public purposes in the Office of the City Clerk.

Section 3. This Ordinance shall be in full force and effect upon its passage and approval according to law.
