

ORDINANCE 2015-001 PASSED: JANUARY 12, 2015

**AMENDING CHAPTER 51 "TRAFFIC", SCHEDULE C
"PARKING PROHIBITED" (GARDEN ROAD
PARKING RESTRICTIONS) OF THE MUNICIPAL
CODE OF THE CITY OF DEKALB, ILLINOIS.**

WHEREAS, the City of DeKalb, DeKalb County, Illinois is a home rule community with those powers granted under the provisions of the Illinois Constitution and the Illinois Municipal Code, 65 ILCS 5/1-1-1, *et. seq.*; and,

WHEREAS, the City of DeKalb has the authority pursuant to the Illinois Municipal Code and its home rule powers to impose parking restrictions within the City of DeKalb; and,

WHEREAS, the City Council finds that the alteration of parking restrictions as contemplated below is required to properly promote the public health, safety, welfare and morals; and,

THEREFORE BE IT ORDAINED by the Mayor and City Council of the City of DeKalb, DeKalb County, Illinois, as follows:

Section 1. Ordinances Amended.

Subsection (3) of Schedule C of Chapter 51 of the City Code of Ordinances is hereby amended with the following additions:

- (3) No Parking 2:00am to 6:00am.

The east side of Garden Road from a point 253 feet North of the Northerly Right of Way line of Lucinda Avenue to a point 630 feet North of the Northerly Right of Way Line of Lucinda Avenue.

The east side of Garden Road from a point 798 feet North of the Northerly Roadway line (extended) of Northern Lane to a point 75 feet South of the Southerly Right of Way Line of Hillcrest Drive.

Subsection (1) of Schedule C of Chapter 51 of the City Code of Ordinances is hereby amended with the following additions:

- (1) No Parking at Any Time:

The east side of Garden Road from the Northerly Right of Way Line of Lucinda Avenue to a point 253 feet North.

The east side of Garden Road from a point 690 feet North of the Northerly Right of Way Line of Lucinda Avenue to a point 798 feet North of the Northerly Roadway Line (extended) of Northern Lane.

The east side of Garden Road from a point 75 feet South of the Southerly Right of Way Line of Hillcrest Drive to a point 45 Feet North of the Northerly Right of Way Line of Hillcrest Drive.

Subsection (31) of Schedule C of Chapter 51 of the City Code of Ordinances is hereby amended with the following additions:

The east side of Garden Road from a point 630 feet North of the Northerly Right of Way Line of Lucinda Avenue to a point 690 feet North of the Northerly Right of Way Line of Lucinda Avenue.

Schedule C shall be amended to remove any conflicting reference to parking restrictions on the east side of Garden Road between Lucinda Drive and West Hillcrest Drive.

Section 2. All ordinances or portions thereof in conflict with this ordinance are hereby repealed.

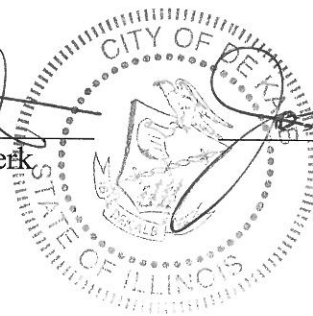
Section 3. Should any provision of this Ordinance be declared invalid by a court of competent jurisdiction, the remaining provisions will remain in full force and affect the same as if the invalid provision had not been a part of this Ordinance.

Section 4. Upon its passage and approval according to law, this Ordinance shall, by authority of the City Council, be published in pamphlet form. On the tenth day after the date of publication, this Ordinance shall be in full force and effect. Publication date: January 13, 2015. Effective date: January 23, 2015.
