

ORDINANCE 2015-002

PASSED: JANUARY 26, 2015

AMENDING CHAPTER 51 "TRAFFIC", SECTION 51.17
"MUNICIPAL PARKING LOTS AND PARKING STALLS"
(SEVENTH STREET PARKING LOT RESTRICTIONS) OF THE
MUNICIPAL CODE OF THE CITY OF DEKALB, ILLINOIS.

WHEREAS, the City of DeKalb, DeKalb County, Illinois is a home rule community with those powers granted under the provisions of the Illinois Constitution and the Illinois Municipal Code, 65 ILCS 5/1-1-1, *et. seq.*; and,

WHEREAS, the City of DeKalb has the authority pursuant to the Illinois Municipal Code and its home rule powers to impose parking restrictions within the City of DeKalb; and,

WHEREAS, the City Council finds that the alteration of parking restrictions as contemplated below is required to properly promote the public health, safety, welfare and morals; and,

THEREFORE BE IT ORDAINED by the Mayor and City Council of the City of DeKalb, DeKalb County, Illinois, as follows:

Section 1. Ordinances Amended.

Section 51.17 of the City Code of Ordinances is hereby amended with the addition of a subsection (o) as follows:

o) Seventh Street Parking Lot: The City of DeKalb owned parcel located at 220 N. Seventh Street and located on the east side of Seventh Street, south of Oak Street and north of the railroad tracks, shall be a permitted area for public parking. Parking in the Seventh Street Parking Lot shall be prohibited every day between 2:00 am and 6:00 am.

Section 2. All ordinances or portions thereof in conflict with this ordinance are hereby repealed.

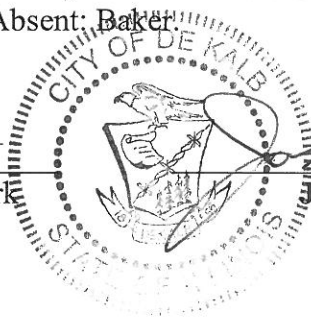
Section 3. Should any provision of this Ordinance be declared invalid by a court of competent jurisdiction, the remaining provisions will remain in full force and affect the same as if the invalid provision had not been a part of this Ordinance.


Section 4. Upon its passage and approval according to law, this Ordinance shall, by authority of the City Council, be published in pamphlet form. On the tenth day after the date of publication, this Ordinance shall be in full force and effect. Publication date: January 27, 2015. Effective date: February 5, 2015.
