

**ORDINANCE 13-59 Passed: October 14, 2013**

**AMENDING THE MUNICIPAL CODE OF THE CITY OF DEKALB, ILLINOIS CHAPTER 51, "TRAFFIC," SECTION 51.13, " PARKING PROHIBITED," SCHEDULE C, "NO PARKING ANY TIME" BY CHANGING A PORTION OF PERSIMMON STREET NORTH OF KNOLLS AVENUE SOUTH.**

**BE IT ORDAINED BY THE CITY COUNCIL** of the City of DeKalb, Illinois as follows:

**Section 1.** That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.13, "Parking Prohibited" Schedule C, "No parking anytime to be amended by the following:

Amend Schedule C, Parking Prohibited:

~~Delete Persimmon Street, West and North sides, from the North right-of-way line of Knolls Avenue South 550 feet Northerly to the circle terminus.~~

**Section 2.** That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.13, "Parking Prohibited" be amended by the following:

Add to Schedule C, Parking Prohibited.

Persimmon Street, west side from a point 267 feet North of the North right-of-way line of Knolls Avenue South through the circle terminus to the East side of Persimmon Street to a point 286 feet north of the North right of way line of Knolls Avenue South.

**Section 3.** That each section, paragraph, sentence, clause and provision of this ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this ordinance, nor any part thereof, other than that part affected by such decision.

**Section 4.** That except as to the amendments heretofore mentioned, all Sections of the Municipal Code of the City of DeKalb, Illinois shall remain in full force and effect.

**Section 5.** Upon its passage and approval according to law, this Ordinance shall, by authority of the City Council be published in pamphlet form. On the tenth day after the date of publication, this Ordinance shall be in full force and effect. Publication date: October 14, 2013. Effective date: October 24, 2013.
