

AMENDING THE MUNICIPAL CODE OF THE CITY OF DEKALB, ILLINOIS CHAPTER 51, "TRAFFIC," SECTION 51.13, "PARKING PROHIBITED," SCHEDULE C, TO ADD "NO PARKING AT ANY TIME," ALONG THE NORTH SIDE OF GREENBRIER ROAD AND ALLOW PARKING ALONG THE SOUTH AND WEST SIDE.

BE IT ORDAINED BY THE CITY COUNCIL of the City of DeKalb, Illinois as follows:

Section 1. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic" Section 51.13, "Parking Prohibited," Schedule C, 1, "No Parking at Any Time," be amended by adding the following in the appropriate place:

Greenbrier Road, North side between Normal Road to Hillcrest Drive

Section 2. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic" Section 51.13, "Parking Prohibited" Schedule C, "No Parking 10:00 a.m. to 4:00 p.m.," be amended by deleting the following in the appropriate place:

~~**Greenbrier Road, North side, between Hillcrest Drive and Normal Road**~~

Section 3. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic" Section 51.13, "Parking Prohibited" Schedule C, "No Parking 10:00 a.m. to 4:00 p.m.," be amended by deleting the following:

~~**Greenbrier Road, South side, between Hillcrest Drive and Normal Road**~~

Section 4. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic" Section 51.13, "Parking Prohibited," Schedule C, 18, "No Parking at Any Time Except for Residents," be amended by changing the title to "No Parking At Any Time Except for Residents: Tow Zone", and by inserting the following in the appropriate place:

Greenbrier Road, South side between Normal Road to Hillcrest Drive

Section 5. That each section, paragraph, sentence, clause and provision of this ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this ordinance, nor any part thereof, other than that part affected by such decision.

Section 6. That except as to the amendments heretofore mentioned, all Sections of the Municipal Code of the City of DeKalb, Illinois shall remain in full force and effect.

Section 7. Upon its passage and approval according to law, this Ordinance shall, by authority of the City Council be published in pamphlet form. On the tenth day after the date of publication, this


Ordinance shall be in full force and effect. Publication date: October 15, 2013. Effective date: October 15, 2013.
