Annie Glidden Road and Fairview Drive intersection improvement including widening, pavement repair, resurfacing, traffic signal relocation, lighting improvements, drainage improvements, erosion control and restoration. Motor Fuel Tax funds identified herein will be used for Phase I, Phase II and ROW Acquisition.

2. That there is hereby appropriated the sum of Two hundred and seventy-five thousand

Dollars (\$275,000.00) for the improvement of
