

RESOLUTION 2017-089

PASSED: JULY 24, 2017

**RELATING TO THE PARTICIPATION OF THE MAYOR
OF THE CITY OF DEKALB, ILLINOIS IN THE
ILLINOIS MUNICIPAL RETIREMENT FUND.**

WHEREAS, the City of DeKalb, DeKalb County, Illinois, is a home-rule municipality with the power and authority conferred thereupon by the City Code of the City of DeKalb, the Illinois Municipal Code and the Constitution of the State of Illinois; and

WHEREAS, pursuant to the rules of the Illinois Municipal Retirement Fund, the City is obligated to declare whether the Mayor of the City of DeKalb shall participate in such fund or receive potential benefits from such fund; and

WHEREAS, the Mayor has determined to not participate in such fund and the City Council is desirous of approving of the same.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

Section 1: The City Council of the City of DeKalb hereby determines and declares that the Mayor of the City of DeKalb shall not participate in Illinois Municipal Retirement Fund benefits. The Mayor and City staff are authorized and directed to complete all documentation required to effectuate such direction, including but not limited to, Illinois Municipal Retirement Fund specimen resolutions, as if fully approved, authorized and incorporated herein. Nothing contained herein shall limit the authority of the City to later change this designation or to offer Illinois Municipal Retirement Fund benefits to the position of Mayor of the City of DeKalb, if determined appropriate at a later date.

Section 2: That the City Clerk of the City of DeKalb, Illinois, be authorized and directed to attest the Mayor's Signature and shall be effective thereupon. The City Clerk or designee shall also be authorized and directed to attest the Mayor's Signature upon any agreement developed pursuant to this Resolution.

PASSED BY THE CITY COUNCIL of the City of DeKalb, Illinois, at a Regular meeting thereof held on the 24th day of July, 2017, and approved by me as Mayor on the same day.
