AUTHORIZING THE 2017 LEVY AND 2018 COLLECTION OF TAXES IN AND FOR THE CORPORATE AND MUNICIPAL PURPOSES AND SPECIAL SERVICE AREAS OF THE CITY OF DEKALB FOR THE FISCAL YEAR 2018.

WHEREAS, the Corporate Authorities of the City of DeKalb, DeKalb County, Illinois, have budgeted such sums of money as are deemed necessary to defray all necessary expenses and liabilities of the municipality, including the amounts to be deposited in the reserves provided for in the Illinois Pension Code, as now and hereafter amended, for the fiscal year beginning January 1, 2018 and ending December 31, 2018; and

WHEREAS, the Corporate Authorities of the City of DeKalb, a home rule municipality, may levy taxes upon all property subject to taxation within the municipality, as that property is assessed and equalized for State and County purposes for the current year; and

WHEREAS, it is deemed necessary and in the best interests of the City of DeKalb to levy such taxes to defray a portion of the municipality's expenses, as set forth in this Ordinance; and

WHEREAS, IN 1990, the City of DeKalb established the City of DeKalb Special Service Area No. 3 ("**SSA No. 3**"); and

WHEREAS, the City may levy and extend taxes upon real property within SSA No. 3 on an annual basis within SSA No. 3; and

WHEREAS, the City Council have determined that it is necessary, appropriate, and in the best interests of the City and its residents to levy and extend taxes upon real property within SSA No. 3, as set forth in this Ordinance; and

WHEREAS, IN 1994, the City of DeKalb established the City of DeKalb Special Service Area No. 4 ("**SSA No. 4**"); and

WHEREAS, the City levies and extends taxes upon real property within SSA No. 4 on an annual basis within SSA No. 4; and

WHEREAS, the City Council have determined that it is necessary, appropriate, and in the best interests of the City and its residents to levy and extend taxes upon real property within SSA No. 4, as set forth in this Ordinance; and

WHEREAS, IN 2004, the City of DeKalb established the City of DeKalb Special Service Area No. 6 ("**SSA No. 6**"); and

WHEREAS, the City levies and extends taxes upon real property within SSA No. 6 on an annual basis within SSA No. 6; and

WHEREAS, the City Council have determined that it is necessary, appropriate, and in the best interests of the City and its residents to levy and extend taxes upon real property within SSA No. 6, as set forth in this Ordinance; and

WHEREAS, IN 2013, the City of DeKalb established the City of DeKalb Special Service Area No. 14 ("**SSA No. 14**"); and

WHEREAS, the City levies and extends taxes upon real property within SSA No. 14 on an annual basis within SSA No. 14; and

WHEREAS, the City Council have determined that it is necessary, appropriate, and in the best interests of the City and its residents to levy and extend taxes upon real property within SSA No. 14, as set forth in this Ordinance; and

WHEREAS, the purpose of the special service area levies are to provide funds for the provision of special services within the geographic limits of the special service area, with such services being in accordance with the permitted purposes of the special service area; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of DeKalb, DeKalb County, Illinois, as follows:

Section 1: The recitals set forth above are hereby incorporated herein by reference and made a part of Section 1 of this Ordinance.

Section 2: The Fiscal Year 2018 budget appropriations having been made heretofore by the Mayor and City Council of the City of DeKalb, DeKalb County, Illinois, at a meeting convened and held on November 27, 2017, and the amounts to be levied for each fund of the City of DeKalb are hereby ascertained as set forth below in the column entitled "Levy":

Section 3: The sum of Eight Million, Three Hundred and Three Thousand, and Ninety-Four dollars (\$8,303,094), the same being that part of the total budget for the fiscal year 2018, heretofore made for corporate and municipal purposes of the City of DeKalb, to be collected from the tax levy for fiscal year 2018, shall be and the same is hereby levied upon all taxable property in the City of DeKalb for said fiscal year.

Section 4: Separate tax levies shall also be extended by the Clerk of DeKalb County to pay outstanding bonds and interest in the amount of Three Million, Nine Hundred Forty-Eight Thousand, Nine Hundred, and Seven dollars (\$3,948,907) as set forth in the bond ordinances on file with the Clerk of DeKalb County, Illinois.

Section 5: The City of DeKalb hereby levies \$1,000.00 in taxes for the tax levy year 2017, collection year 2018 and fiscal year 2018, against all taxable property within SSA No. 3.

Section 6: The City of DeKalb hereby levies \$5,500.00 in taxes for the tax levy year 2017, collection year 2018 and fiscal year 2018, against all taxable property within SSA No. 4.

Section 7: The City of DeKalb hereby levies \$18,000.00 in taxes for the tax levy year 2017, collection year 2018 and fiscal year 2018, against all taxable property within SSA No. 6.

Section 8: The City of DeKalb hereby levies \$2,500.00 in taxes for the tax levy year 2017, collection year 2018 and fiscal year 2018, against all taxable property within SSA No. 14.

Section 9: The Clerk of the City of DeKalb is hereby directed to file with the Clerk of DeKalb County, Illinois, forthwith, a copy of this Ordinance duly certified under the Corporate Seal of the City of DeKalb as provided by law.

Section 10: This Tax Levy Ordinance is adopted pursuant to the procedures set forth in the Illinois Municipal Code, as amended, provided, however, any tax rate limitation or any other substantive limitations as to tax levies in the Illinois Municipal Code, Revenue Act or other statute in conflict with this Ordinance shall not be applicable to this Ordinance pursuant to Section 6 of Article 7 of the Illinois Constitution. The invalidity of any section or provision of

this Ordinance hereby adopted and approved shall not invalidate other sections or provisions thereof.

Section 11: Upon its passage and approval according to law, this Ordinance shall, by authority of the City Council, be published in pamphlet form. On the tenth day after the date of publication, this Ordinance shall be in full force and effect.
