**AUTHORIZING A 17-MONTH PURCHASING AGREEMENT EXTENSION WITH PETROLEUM TRADERS CORPORATION FOR THE PURCHASE OF VEHICLE FUEL FOR THE PERIOD OF AUGUST 1, 2019 TO DECEMBER 31, 2020.**

**BE IT RESOLVED BY THE CITY COUNCIL** of the City of DeKalb, Illinois, as follows:

**SECTION 1.** That the Mayor of the City of DeKalb be authorized and directed to enter into a 17-month contract extension of a purchasing agreement with Petroleum Traders Corporation for the purchase of vehicle fuel for a period of August 1, 2019 to December 31, 2020 with two additional one-year terms possible, in a form acceptable to him with the recommendation of the City Manager.

**SECTION 2.** That the City Clerk of the City of DeKalb be authorized and directed to attest the Mayor's signature.


