

RESOLUTION 2019-112

PASSED: JULY 8, 2019

AUTHORIZING THE CITY MANAGER TO ENTER INTO A PURCHASE AGREEMENT WITH THE KISHWAUKEE WATER RECLAMATION DISTRICT FOR THE PURCHASE OF A VEHICLE IN THE AMOUNT OF \$57,500.

WHEREAS, the City of DeKalb is a home rule unit as defined in Article VII, Section 6(a) of the 1970 Illinois Constitution and has jurisdiction over matters pertaining to its government and affairs; and

WHEREAS, it is in the best interest of the City to purchase vehicles and equipment for the Public Works Department; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: That the City Council of the City of DeKalb hereby authorizes the City Manager to enter into a purchase agreement with the Kishwaukee Water Reclamation District, for the purpose of purchasing one used 2004 Sterling L7501 single axle truck with 2003 Vactor 2110 in an amount of \$57,500, and thereafter that the City staff is authorized and directed to take all actions necessary to equip such vehicle for utility purposes without requiring further authorization or approval of City Council, provided that any costs or expenses to be incurred within the present budget year are within the scope of the then approved budget, and provided that any expenditures proposed to be incurred in future years shall require Council approval through passage of a future budget.

SECTION 2: That the City Clerk of the City of DeKalb, Illinois be authorized and directed to attest the Mayor's Signature and shall be effective thereupon.


